# Pure Water Project Las Virgenes – Triunfo Demonstration Facility Set to Open

*After years of planning and preparing, the Las Virgenes – Triunfo Joint Powers Authority (JPA) will begin showcasing the advanced treatment of recycled water to educate and inform the community of the future of potable water at its new demonstration facility.*

**Calabasas, CA** – As all Californians know, clean water is a resource that we all share. With increasing water demands driving competition for this finite resource and climate change creating weather pattern uncertainty, the JPA is committed to ensuring long-term water supply reliability for our communities.

The JPA’s joint service area, including portions of Los Angeles County and Ventura County, receives 100% of its drinking water supply from the Sierra Nevada Mountains via the State Water Project. The water travels over 400 miles to reach us and requires a significant amount of energy to pump it over mountain ranges on its way.

Because of challenging and costly regulatory requirements regarding Malibu Creek and the continued threat of wildfires and drought, not to mention the potential for a major earthquake that could cut off our imported water supply, the JPA sought to create a local source of drinking water supply that protects everyone from a significant disruption in water service.

“The JPA has always been forward-thinking and proactive in finding solutions to emerging uncertainties to protect our communities and ensure reliable water and wastewater services, said Jay Lewitt, JPA Board Chair. “By bringing water full circle, this demonstration project provides certainty to our customers, while closing the sustainability loop through reusing recycled water as a drinking water source, rather than discharging it to Malibu Creek.”

Since 1972, the JPA has supplied recycled water for outdoor irrigation at our parks, schools, golf courses, medians, and athletic fields. The Pure Water Project Las Virgenes-Triunfo will take the unused portion of that recycled water and advance treat it using the proven technology of ultrafiltration, reverse osmosis, and ultraviolet light to create a product that is quite literally, an H<sub>2</sub>O molecule.

While the full-scale project is still years away from being built, the demonstration facility will serve to educate customers on the effectiveness and safety of the advanced water treatment process, test alternative treatment equipment to reduce long-term operating costs for the full-scale facility and train employees in the operation of a membrane treatment plant.

The total cost of the demonstration facility was \$3.2 million, but that amount was significantly offset through federal, state and local agency grants, totaling \$2.2 million.
