Candidate for TWSD Board of Directors Vacancy:

Notice is hereby given that at the Special Board Meeting being convened on July 15, 2026, the Triunfo Water & Sanitation District Board of Directors will appoint a resident of the District from the group of submitted applications to fill the vacancy created by Director Raymond Tjulander. The meeting will take place at 5:15 p.m. in the TWSD Office, Board Room, located at 370 N. Westlake Blvd., Suite 100, Westlake Village, California.

The Board will interview all verified applicants whose completed packet was received by July 8, 2026. Each applicant will be given a few minutes to make brief introductory comments and state their reasons for desiring to become a Board member and their qualifications. The Board may ask questions related to the candidate's application or presentation.

The order of the interviews will be by a lottery with each applicant's name being placed in a container and drawn by the Chair of the Board. Following the completed interview process of all applicants, the Board members will take a brief moment to rank their selections and then discuss and select the new Director. The decision of the Board will be final. The new Director will be sworn in at the July 15, 2026, Special Board Meeting, and the Oath of Office will be administered.

Thank you for your interest in serving on the TWSD Board.

CLARIFICATION ON TERM OF VACANCY: Pursuant to Government Code §1780, the person appointed to fill the vacancy will serve until the next general district election. The person then elected to fill the vacancy shall hold the office for the unexpired balance of the term of office. Accordingly, the applicant appointed by the Board will serve through December 2026. To continue serving beyond that date, the appointee, like any other candidate, must file to run in the November 2026 General District election during the nomination period which opens July 13 and closes August 12, 2026. The person elected in that election will serve through December 2030.
